- Candidates must bring 2 latest passport size photographs at the time of interview.
- In case, any certificate/testimonial of an applicant is found fake at any stage of recruitment or issued by an incompetent authority, the eligibility/appointment of that applicant would be cancelled with immediate effect and a legal action may be taken against him/her. If any candidate is found not to be fulfilling the eligibility/selection criteria at the time of interview or at any point of time in the entire recruitment process by the screening or selection committee, his/her candidature will be cancelled/ rejected for the said post.
- Appearing for Walk in Interview does not imply that candidate has fulfilled all the criteria given in the advertisement and he/she is eligible for the post. Eligibility of the candidate will be determined after thorough scrutiny of the application filled by the candidate. If candidate found not eligible by screening committee, he will not be allowed to appear in the interview before the selection committee.
