Subject:- Release of Untied Funds to Sub Centres, Primary Health Centres and Community Health Centres under NRHM

Sir,

Please refer to the subject cited above.

Government of India, Ministry of Health & Family Welfare, Nirman Bhawan, New Delhi has released Untied Funds @ Rs. 10,000 per Sub Centre (SCs), @ Rs. 25,000/- per PHC and Rs. 50,000/- per CHC for all the SCs, PHCs and CHCs of the State of Punjab under NRHM.

2. These **Untied Funds** are to be utilized strictly according to the guidelines provided by Govt. of India (copies enclosed). At present, Punjab State has 20 districts with 2858 Sub Centres, 484 PHCs/ Mini PHCs and 128 CHCs functioning therein. Accordingly, the allocation of funds to all the districts has been made as under:-

3. Untied funds at the sub centre level are to be used for the purchase of daily use small items. Funds are to be kept in Joint Bank Account of ANM and the Sarpanch of the village.

5. Since presently PHC level Rogi Kalyan Samities/ Hospital Management Committees are not in position and as per discussion held and advice given by MOHFW, GOI in the National NRHM review meeting held at New Delhi under the Chairpersonship of Smt. S.Jalaja the then Additional Secretary, an alternate Committee for this purpose named as **PHC Management Committee headed by Senior Medical Officer/ Medical Officer Incharge PHC/ Mini PHC** has already been constituted as conveyed to all the Civil surgeons vide this office letter No. NRHM (M&E) Pb/2007/ 1513-36 dated 05.04.2007.

This Committee will execute all the functions regarding utilisation of untied funds at the PHC till Rogi Kalyan Samiti is in position. All decisions/ resolutions in this regard shall have the approval of the Committee with a quorum of 2/3rd of the members of the Committee. In case of a tie, head of the Committee shall have the deciding vote.

These PHC funds under NRHM will be kept in a separate joint bank account in the name of PHC Management Committee and will be operated jointly by the SMO/ MO Incharge PHC and Sarpanch/ Panch of the village where PHC is situated.

Untied Funds for CHCs are to be kept in the Bank Account of Rogi Kalyan Samiti (RKS) / Hospital Management Committee.
